# Volunteer Firefighter Personal Protective Equipment (PPE) Grant Funding Overview

## Description

The SD Volunteer Firefighter Personal Protective Equipment (PPE) Grant program provides funding authorized by SB 136 from the 2026 SD Legislative Session for volunteer fire departments to purchase needed firefighter PPE.

Eligible volunteer fire departments must be a SD Certified Fire Department per the SD State Fire Marshal's Office and have a membership comprised of at least 70% volunteer firefighters. The requesting fire department does not need to be a member of the South Dakota Firefighters Association.

**All PPE purchased must meet current NFPA or other nationally recognized standards.**

**Equipment eligible for this program includes but may not be limited to:**

- Structural personal protective equipment – helmets, shroud, gloves, coats, pants, suspenders and boots.
- Rescue personal protective equipment – jacket, pants, helmets, gloves, boots and goggles.
- Wildland personal protective equipment – helmets, shroud, goggles, gloves, shirt, pants, boots & fire shelters.
- Self-contained breathing apparatus and one spare tank per unit.
- Other personal protective gear that may be required by individual volunteer fire departments – chain saw chaps, ice rescue suits, traffic safety vests, etc.

**Equipment not eligible for this program includes but may not be limited to:**

- Wildland backpacks, flashlights, other gear not determined to be PPE. (If you have questions, contact the Fire Marshal's Office)

## Project Timeline/Application Deadlines

Applications must be received by **August 1, 2026**.

Any unallocated funding will be awarded through additional application periods until funding is depleted.

## Funding/Reimbursement

PPE expenses can be submitted for and reimbursement once the PPE order is received and the VFD has an invoice from the vendor. Departments will need to submit the completed Reimbursement Request Form (included with the project agreement packet once awarded) and the supporting invoices to the State Fire Marshal's Office. No grant reimbursements will be made directly to the vendor.

## Project Completion

All projects must be completed no later than **18** months from the agreement start date.
